Inhaled	<p>The material is not thought to produce either adverse health effects or irritation of the respiratory tract following inhalation (as classified by EC Directives using animal models). Nevertheless, adverse systemic effects have been produced following exposure of animals by at least one other route and good hygiene practice requires that exposure be kept to a minimum and that suitable control measures be used in an occupational setting.</p> <p>A vapour/mist containing chlorinated paraffins of more than 10 carbon atoms and a chlorine content ranging between 40 and 70% may produce a sore throat, coughing and shortness of breath.</p> <p>Inhalation hazard is increased at higher temperatures.</p>
Ingestion	<p>Accidental ingestion of the material may be damaging to the health of the individual.</p> <p>Chlorinated paraffins can cause liver damage and wasting of heart muscle. Large amounts can cause abdominal pain, nausea, vomiting, as well as inactivity, inco-ordination and diarrhoea.</p>
Skin Contact	<p>Repeated exposure may cause skin cracking, flaking or drying following normal handling and use.</p> <p>There is some evidence to suggest that this material can cause inflammation of the skin on contact in some persons.</p> <p>Chlorinated paraffins of more than 10 carbon atoms and a chlorine content ranging between 40 and 70% may be absorbed by the skin and produce areas of localised reddening.</p> <p>Exposure to the material may result in a skin inflammation called chloracne. This is characterised by white- and blackheads, keratin cysts, spots, excessive discolouration.</p> <p>Open cuts, abraded or irritated skin should not be exposed to this material</p> <p>Entry into the blood-stream, through, for example, cuts, abrasions or lesions, may produce systemic injury with harmful effects.</p> <p>Examine the skin prior to the use of the material and ensure that any external damage is suitably protected.</p>

Special consideration should be given to solid grades of the material (eg Cereclor 70) because of relatively high levels of carbon tetrachloride remaining as a residual reactant. Vapours are readily absorbed through intact skin, requiring additional precautions in handling.</p> <p>Lifetime studies have been carried out with two grades of chlorinated paraffins. A short-chain grade with 58% chlorine caused tumours in rats and mice.</p>
